Building on "the New Normal"

There is a lot of talk about the "new normal" in our way of life, including in clinical development, borne from the fact that the COVID-19 pandemic is not over by half. Trials are underway around the world, and in their latest update, in August, the WHO indicated a realistic timeframe of early 2021 for when vaccines will roll out. The time-determinants include ensuring rigorous clinical testing and approval, as well as ramping up of production and distribution.

In clinical research as well, reports indicate we are finally learning how to live with the situation, and that trials are restarting. As of March 31, 2020, more than 9,250 industry-funded clinical trials were impacted, but a recent report has shown that the number of disrupted trials began to fall between June and July, after three months of increasing trial disruptions, mainly due to the resumption of trials which had suspended enrollment due to the pandemic.

Here, I'd like to highlight a number of "design element" modifications to the trial process driven by patient data technologies which are mitigating the negative impacts to recruitment arising from the pandemic.
