#### Conference Roundup

November is a busy time for the clinical trial conference industry, and the Clinerion team was on the road engaging current and prospective clients. In the space of two weeks we visited three conferences, the World Orphan Drug Congress in [Geneva World Orphan Congress](#), the [Clinical Operations Strategy Meeting USA](#) Proventa event in Boston and [Partnerships in Clinical Trials](#) in Hamburg. We had a number of meetings, spoke to our current and potential clients and came back with a lot of new ideas.

#### *What did We Learn?*

We learned, once again, that our **PRS platform is great for orphan diseases**. The ability to search millions of LIVE hospital records in minutes, telling pharma companies where eligible patients with rare diseases are, has consistently put the people we spoke to in a state of disbelief. Especially since most of the times we were able to find more patients than they hoped for.

We heard that the solutions that are currently on the market allow one to find out where the patients were before a trial starts, but don't help to **identify patients after the study has begun**. And an investigator still has to search for patients using traditional/manual methods, as opposed to the PRS platform that will provide a ready list of trial candidates to the investigator before and during the entire recruitment phase.

We were also able to discuss a number of **future applications** for our system. The most notable ones are **real world evidence, post-marketing studies, market access activities**, integration with electronic data capture (EDC) and data driven hospital management decision support. The ability to run complex queries in real time on patient data without compromising patient confidentiality and data security is still a new, but once people realize what is possible, suggestions for what can be done with it start

flooding in.

We will soon update our conference plan for 2016 – we have planned a number of conferences in Europe and USA , and we are looking forward to seeing you at one of the events!
